## Quick Start Guide

### Sync Your Satellite With the NETGEAR Orbi App



You can use the NETGEAR Orbi app to sync your satellite to your router.

To find the app, scan a QR code or search for NETGEAR Orbi in the Apple App Store or Google Play Store.

**Note:** If you don't own a mobile device, follow the instructions in the next section.

1. Launch the NETGEAR Orbi app.
2. Tap the menu icon ≡ > **ADD SATELLITE.**
3. Follow the prompts to sync your satellite.

### Manually Sync Your Satellite With Your Router

If you don't want to use the app to sync your satellite to your router, follow these steps:

1. Place and plug in your satellite.  
For more information about where to place your satellite, see the user manual.
2. Press the **Sync** button on the back of your satellite, and within two minutes, press the **Sync** button on the back of your router.

### Satellite Sync LED Colors

The satellite's ring LED lights white while the satellite attempts to sync with the router, lights one of the following colors for about three minutes, and then turns off:

- **Blue**  
The satellite successfully synced to the router, and the connection between the router and satellite is good.
- **Amber**  
The satellite successfully synced to the router, and the connection between the router and satellite is fair. Consider moving the Orbi satellite closer to the Orbi router.
- **Magenta**  
The satellite failed to sync to the router. Move the satellite closer to the router and try again.
